1. Website ownership and acceptance of the terms and conditions

Please read these Terms and Conditions of Use (hereinafter '**Terms and Conditions of Use**') before using the <u>www.fastpayhotels.com</u> website (hereinafter '**the Website**').

The Terms and Conditions of Use govern the relationship between website users (the 'User') and Fastpayhotels, S.L. ('Fastpayhotels'), a Spanish company listed in the Palma de Mallorca Copanies Register in Volume 2635, Page 19, Sheet PM-77490 with registered business address at Calle Pare Antoni Oliver 2-8, Palma de Mallorca 07014, Spain, with Spanish Tax ID B-57940066 number and the following email address: info@fastpayhotels.com.

When you use the Website, you agree to accept these Terms and Conditions of Use.

2. Website use

The Website is available to all Users subject to the Terms and Conditions of Use. Users agree not to use the Website for illegal or prohibited purposes. Users agree not to introduce or disseminate computer viruses or damage, render unusable, overload, deteriorate or prevent the normal use of the Website, the information systems, or the documents, files and all types of contents hosted on any computer hardware (hacking) that is the property of Fastpayhotels or any User.

3. Intellectual and industrial property

All of the content on the Website, including its design, structure and layout, text and content, logos, buttons, images, drawings, brand names, tradenames, source codes and artwork, as well as all intellectual and industrial property rights, and all other distinctive signs is owned by or has been assigned to Fastpayhotels. Use and access to the Website and use of its services does not confer the User with any rights in the above content.

The reproduction, exploitation, modification, distribution or public communication of the Website is strictly forbidden.

4. Cookies policy

The Website may use cookies when accessed by a User.

Cookies are small files that are downloaded onto your computer when you access certain websites. Among other things, cookies enable websites to save and recover information regarding a User's browsing habits or their hardware. In addition, and depending on the type of information contained and the way the hardware is used, they may also be used to recognise the User.

The following types of cookies may be used by this Website.

• Own cookies: they are sent to the User's terminal from hardware or a domain managed by the editor and from which the service requested by the User is provided.

- Third party cookies: they are sent to the User's terminal from hardware or a domain that is not administered by the editor, but instead by another organisation that processes the data obtained via the cookies.
- Session cookies: this type of cookie is designed to collect and store data while the User is accessing a website.

Fastpayhotels may collect the following personal information provided by the User (hereinafter 'Personal Information') as of the time of access to the Website:

- Name and surname, ID data and business name, physical and email addresses and telephone number.

- The IP address from which the site is accessed.

-Storage of cookies on the User's computer hard drive, subject to the User's prior consent. Fastpayhotels uses cookies in order to provide information that is more closely tailored to the User's interests.

When using the data stored on the file, Fastpayhotels undertakes to respect their confidential nature and to used them in accordance with the purposes of the file, as well as to comply with its obligation to store them and take all necessary measures to prevent their variation, loss and unauthorised access or processing pursuant to the terms and conditions of Royal Decree 1720/2007, of 21st December, approving the implementation provisions of the OLDP.

The User expressly consents to the processing of personal data for the following purposes:

- a) The provision by Fastpayhotels of the services specifically requested by the User.
- b) The sending of its own commercial information (service offers and promotions).
- c) Notification to Users of service-related issues.
- d) Conducting of studies and statistical analyses.
- e) General problem solving.
- f) Data comparisons in order to guarantee their accuracy.
- g) All other purposes with the aim of improving Website use.

By accessing or using the Website, Users specifically consent to receiving these email messages, although they may unsubscribe (i) via the link given in all email communications or (ii) by sending an email to info@fastpayhotels.com.
